### SOC174 (HMNR 100): Introduction to Human Rights and Global Justice

In this course, we will explore the origins and meanings of human rights by situating them within the history of modern society. We will trace the development of the contemporary human rights regime and take a closer look at a wide array of rights -- from the right to life, liberty and freedom of expression, through economic and political rights, to women's and refugees' rights.
